

Product Features

DC-S6481HRA is an IP-based network camera that compresses and transmits video over ethernet. You can use the IDIS Discovery program to change network camera settings or the IDIS Solution Suite Compact program to manage multiple network cameras. In addition, the embedded web server (IDIS Web) lets you remotely view live video or scan recorded video using a web browser. In addition, you can use the IDIS Solution Suite Compact to manage network cameras and view/record video.



In this operation manual, the term **Remote System** refers to the computer on which the remote program (IDIS Solution Suite Compact or IDIS Web) is running.



Alarm In/Out

- ALI:Connect an alarm-in device to this port. (Mechanism: Choose between an NC (Normally Closed) type or an NO (Normally Open) type) → Connect a mechanical or electrical switch to the alarm in port and the GND (ground) connector. Alarm in range is 0V to 5V. In order to detect alarm input from an electrical switch, the signal must be higher than 4.3V from an NC switch or less than 0.3V from an NO switch and must last for longer than 0.5 seconds.
- ALO: It is the BJT (Bipolar Junction Transistor) open collector output. If the voltage and current
 exceed the specification limit (Max load: 50mA,
 Max Voltage: 30VDC), the product could be
 damaged. When connecting the device which
 exceeds the specification limit, refer to the picture
 (circuit) below.



If used with an external inductive load(e.g. relay), a diode must be connected in parallerl with the load for protection. Otherwise, the product could be damaged.



• Audio In/Out, Video Out


- A_I: Connect an audio source to this port. (line in)
- A_O: Connect an amplifier to this port (line out). This device does not feature a built-in audio amplifier unit and therefore requires the user to purchase a separate speaker system with a built-in amplifier.
- V_O, GND: Connect the cable's signal line and ground line to these ports and the connector on its opposite end to a monitor. Use these ports for previewing video and not monitoring video. Go to Remote Setup (Video – Camera menu > Miscellaneous tab) and choose a video out signal. (NTSC or PAL)



When inserting an alarm in/out, audio in/out, or video out, connector, hold down the button and push the connector in through the exposed hole. Release the button and then gently pull on the wire to ensure a secure connection. To disconnect, press down on the button again and pull the wire out.

 Check your local laws and regulations on making video or audio recordings. The user will be held liable for any violation of the law.

- Organize the power cable so that it will not cause people to trip over or become damaged from chairs, cabinets, desks, and other objects in the vicinity. Do not run the power cable underneath carpet or a rug or plug the cable into a power outlet shared by a number of other devices.
- Wrap the camera-end of the earth cable twice around the provided ferrite core for EMC (Electromagnetic Compatibility). If not, you may experience video stuttering.



• The network connector is not designed to be connected directly with cable or wire intended for outdoor use.

Factory Reset

Only use the factory reset button to restore the camera to its factory default settings.



A factory reset will clear all camera settings configured by the user.

- **1** Shut off the power supply.
- **2** Press and hold the reset button down.
- 3 Hold the button down and reconnect the power.
- **4** Once the device turns back on, wait 5 seconds, and then release the reset button.
- **5** The device will go through the resetting process and reboot. All camera settings will be restored to their factory defaults after the reboot.

It's also possible to do a factory reset by pressing and releasing the reset switch while the camera is turned on or using the IDIS Discovery program from a remote location. A factory reset will reboot the system. For more information on factory reset, refer to the **IDIS Discovery operation manual**.


Installation



- Check the wall or ceiling to see if it needs to be reinforced. The camera may fall off if the wall or ceiling is not strong enough to support its weight.
- Install the camera in a shaded area. If the camera is installed in direct sunlight, it may be affected adversely.
- 1 Make a cable hole in the wall or ceiling.

Inserting a SD Memory Card


Insert a SD memory card into the SD memory card slot with the 'micro SD' print facing upward.






Push the SD memory card until it disengages from the slot, and then pull it out.

Make sure that the cover is joined properly when screwing it; otherwise, the IP66 level is not guaranteed.



Bushing

Use a bushing provided with the camera to prevent moisture or water from entering through the bracket or pipe. First, pass the cable through the waterproof bushing, assemble it in the pendant, and then use the waterproof glue provided with the camera to fill the cable gap and the holes.



<Installing to the bracket>


<Installing to the Pipe>

When installing in 1-1/2" PF bracket, assemble mount adapter to the bracket and then assemble the pendant. Hook the safety wire of the camera on the safety wire ring of the bracket.





The bracket must be purchased separately.

3 Assemble the mount adapter to the camera body and secure it by using the mount adapter screws (3 points).




4 Gently push the lever located at the bottom of the pendant to lower it and connect the cable.







5 Assemble the pendant and the body by matching the installation direction guides. Rotate the camera body clockwise to position the reference mark in the upper section and the lower section as shown in the figure.



- **6** Use the allen wrench provided with the camera to secure the 3 screws on the pendant.
- **7** Supply the power.




Use the camera by connecting to DirectIP® NVR or non DirectIP® NVR, VMS such as IDIS Solution Suite Compact.



DirectIP[®] NVR makes it easy to use cameras without extra network configurations. Each camera can be controlled via the DirectIP[®] NVR setup menu, without any PC. For detailed camera settings, please see the camera setting pages of DirectIP[®] NVR manual.

For users using the camera with DirectIP® NVR connection, do not need to consider contents in the camera operation manual.

With non DirectIP® NVR-based Layout



Control the camera over the network from software installed on a computer. Ideal for using the camera over the network from a remote location.

The contents in the camera operation manual are only for users using the camera with non DirectIP® NVR connection or VMS connection such as IDIS Solution Suite Compact.

Troubleshooting

Problem	Check
The main unit won't turn on.	Check the power cable connection.Check the power outlet.
l can't see Live videos.	 Check the camera's power status. Check the network connection status of the computer and the network camera.
lmages are blurry.	 Make sure the lens is clean. If not, clean it using a soft piece of cloth or a brush. Make sure the lens is in focus. Adjust the focus during daytime. If there is too much light coming into the camera or the camera is picking up an overly bright light source, adjust the camera's position/angle accordingly.
Video color appears incorrect.	Check the white balance settings. If using the Auto option, it may take some time for the white balance to be adjusted.
Images are blinking.	If the camera is pointed at the sun or a fluorescent lamp, adjust the camera's angle away.
Lost the admin ID and password and unable to connect to a network camera.	You must perform a factory reset. A factory reset will revert all settings, including network settings, to their factory defaults. After performing a factory reset, make a memo of the admin ID and password as a safety precaution.
Unable to launch IDIS Web.	If the IDIS Web login screen is not loading, check which version of Microsoft Internet Explorer you are using. IDIS Web may not launch properly on versions 10 or below.
