Important Safeguards

1. Read Instructions

All the safety and operating instructions should be read before the appliance is operated.

2. Retain Instructions

3. Cleaning

Unplug this equipment from the wall outlet before cleaning it. Do not use liquid aerosol cleaners. Use a damp soft cloth for cleaning.

4. Attachments

5. Water and/or Moisture

6. Placing and Accessories

7. Power Sources

8. Power Cord

Operator or installer must remove power and TNT connections before handling the equipment.

9. Liahtnina

For added protection for this equipment during a lightning storm, or when it is left unattended and unused for long periods of time, unplug it from the wall outlet and disconnect the antenna or cable system. This will prevent damage to the equipment due to lightning and power-line surges. If thunder or lightning is common where the equipment is installed, use a surge protection device.

10. Overloading




Camera Installation

Removing the Dome Cover

1 Loosen the screws counterclockwise using the Allen wrench provided with the product.




2 Remove the dome cover.



Inserting an SD Memory Card

Insert an SD memory card into the SD memory card slot with the 'micro SD' print facing upward.





Push the SD memory card until it disengages from the slot, and then pull it out.

Installation




- Check the wall or ceiling to see if it needs to be reinforced. The camera may fall off if the wall or ceiling is not strong enough to support its weight.
- Install the camera in a shaded area. If the camera is installed in direct sunlight, it may be affected adversely.
- (If necessary) Attach one end of the safety wire (not provided) to the wall or ceiling, and the other end of the safety wire to the installation location on the camera body.
- 1 Detach the protrusion part from the cable rubber along the dotted line.





Make the LAN cable go through the cable rubber using the protect connector.






It is recommended to use lubricant to move the LAN cable smoothly.



Pull the cable slightly and arrange the rubber as shown below.







To pass through a thin cable or more than two cables, it is advised to finish it using silicon to make sure waterproofed perfectly. (Silicon finishing part — refer to the bottom image.)



4 Assemble the cable rubber to the bottom cover.




5 Attach the enclosed desiccant in the bottom to prevent moisture.



Use the screws, anchor provided with the camera to secure the install body on a wall or a ceiling.



Use the provided guide pattern to check the distance between the screws.



- Connect external devices, the network cable, and the power adapter.



Closing the Dome Cover

1 Attach the double-sided tape to the desiccant first, and attach it to the specified location inside the dome cover as shown below.




Check the location of the wall/ceiling installation hole.





Before closing the dome cover, make sure that the gasket ring is securely fixed.

Pasten the screws for the dome cover clockwise using the Allen wrench provided with the camera.





Remove the protective film inside and outside before closing the dome cover.
