Important Safeguards

1. Read Instructions

2. Retain Instructions

3. Cleaning

Unplug this equipment from the wall outlet before cleaning it. Do not use liquid aerosol cleaners. Use a damp soft cloth for cleaning.

4. Attachments

5. Water and/or Moisture

6. Placing and Accessories

7. Power Sources

You may want to install a UPS (Uninterruptible Power Supply) system for safe operation in order to prevent damage caused by an unexpected power stoppage. Any questions concerning UPS, consult your UPS retailer.

8. Power Cord

Operator or installer must remove power and TNT connections before handling the equipment.

9. Lightning

For added protection for this equipment during a lightning storm, or when it is left unattended and unused for long periods of time, unplug it from the wall outlet and disconnect the antenna or cable system. This will prevent damage to the equipment due to lightning and power-line surges. If thunder or lightning is common where the equipment is installed, use a surge protection device.

10. Overloading


Camera Installation



 Loosen the screws counterclockwise and remove the cover.










Push the SD memory card until it disengages from the slot, and then pull it out.










Make sure that the cover is joined properly when screwing it; otherwise, the IP67 level is not guaranteed.

Waterproof Cable Installation 0.000 1 Insert a round rubber ring (silicone rubber) into 1 the RJ45 jack. 2 Insert the network cable into the waterproof 2 cap, rubber bushing, and waterproof cap body in order. З 13.02


3 Plug in the network cable.



4 Connect the plug terminal to the RJ45 jack.



5 Push the waterproof cap body and cap into the RJ45 jack and rotate it.




6 Lock the waterproof cap into the waterproof cap body.




Not pulling the cable back may cause water to seep in and damage the product.

Installation



- Screw the mounting bracket to the wall or ceiling by using screws(4) and bushings(4) provided with the camera.
- 2 Adjust the camera angle by bending the stand. After fully assembling the joint screws, unscrew it 2 ~ 2.5 turns again and move the cover of the joints of the left 3 places slightly. (The screws should not be completely released to prevent it from falling.) After adjusting the direction of the camera, turn the screw clockwise to secure it completely.



- 3 Connect external devices, network and power adapter.
- 4 Apply power.
