Important Safeguards

1. Read Instructions

All the safety and operating instructions should be read before the appliance is operated.

2. Retain Instructions

The safety and operating instructions should be retained for future reference

3. Cleaning

Unplug this equipment from the wall outlet before cleaning it. Do not use liquid aerosol cleaners. Use a damp soft cloth for cleaning.

4. Attachments

Never add any attachments and/or equipment without the approval of the manufacturer as such additions may result in the risk of fire, electric shock or other personal injury.

5. Water and/or Moisture

Do not use this equipment near water or in contact with water.

6. Placing and Accessories

7. Power Sources

You may want to install a UPS (Uninterruptible Power Supply) system for safe operation in order to prevent damage caused by an unexpected power stoppage. Any questions concerning UPS, consult your UPS retailer.

This equipment should be remain readily operable.

8. Power Cord

Operator or installer must remove power and TNT connections before handling the equipment.

9. Liahtnina

For added protection for this equipment during a lightning storm, or when it is left unattended and unused for long periods of time, unplug it from the wall outlet and disconnect the antenna or cable system. This will prevent damage to the equipment due to lightning and power-line surges. If thunder or lightning is common where the equipment is installed, use a surge protection device.

10. Overloading






Camera Installation

Inserting a SD Memory Card

1 Loosen the screws counterclockwise and remove the cover



Insert a SD memory card into the SD memory card slot with the 'micro SD' print facing upward.





Push the SD memory card until it disengages from the slot, and then pull it out.


3 Close the cover and tighten the screws clockwise.




Make sure that the cover is joined properly when screwing it; otherwise, the IP67 level is not guaranteed.

Waterproof Cable Installation






Insert a round rubber ring (silicone rubber) into the RJ45 jack.




Insert the network cable into the waterproof cap, rubber bushing, and waterproof cap body in order.


3 Plug in the network cable.



Connect the plug terminal to the RJ45 jack.



Push the waterproof cap body and cap into the RJ45 jack and rotate it.



6 Lock the waterproof cap into the waterproof cap body.





Not pulling the cable back may cause water to seep in and damage the product.

Installation



- Check the wall or ceiling to see if it needs to be reinforced. The camera may fall off if the wall or ceiling is not strong enough to support its weight.
- Install the camera in a shaded area. If the camera is installed in direct sunlight, it may be affected adversely.
- (If necessary) Attach one end of the safety wire (not provided) to the wall or ceiling, and the other end of the safety wire to the installation location on the camera body.






- Screw the camera sun shield to the camera using the screw provided with the camera.
- 2 Screw the bottom cover to the wall or ceiling by using screws(4) and bushings(4) provided with the camera.
- 3 Band the stand to adjust the camera angle accordingly. For details, refer to the angle adjustment section.
- 4 Connect external devices, network and power adapter.
- 5 Apply power.




