Important Safeguards

1. Read Instructions

8. Power Cord

Operator or installer must remove power and TNT connections before handling the equipment.

9. Liahtnina

For added protection for this equipment during a lightning storm, or when it is left unattended and unused for long periods of time. unplug it from the wall outlet and disconnect the antenna or cable system. This will prevent damage to the equipment due to lightning and power-line surges. If thunder or lightning is common where the equipment is installed, use a surge protection device.

10. Overloading







Installation

Inserting a SD Memory Card

1 Pull and lift the cover to open.



Insert a SD memory card into the SD memory card slot with the 'micro SD' print facing upward.





Push the SD memory card until it disengages from the slot, and then pull it out.

Close the cover.


Installation

Use the screws provided with the camera to secure the mount bracket on a wall or a ceiling.





- 2 Adjust the angle of the camera module.
- 3 Use the screws to secure the main unit on a wall or a ceiling.



- 4 Connect the main unit with the cable of the camera module.
- 5 Connect external devices, the network cable, and the power adapter.
- 6 Connect the power.
