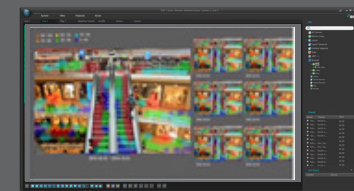

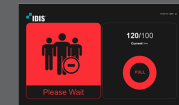
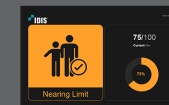
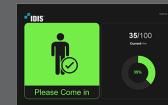
Occupancy Control



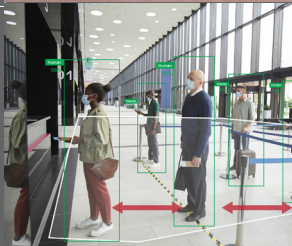
Using 4 cameras at entrances and exits allows for simple and real-time calculations to limit occupancy.

Displays can be customized with logos and images to drive sales of merchandise if customers need to wait in line.

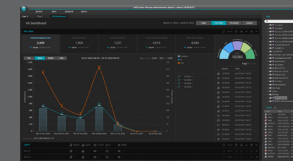


Social Distancing Violations
